# Annual Report 2005-2006

Keeping with its mandate of becoming a centre that encourages serious intellectual pursuits with involvement in the field, during 2005-06 NESRC did field research and got involved in issues of relevance to the Northeast. It developed its library and documentation further and organised some workshops in order to help various ethnic communities to come together. It improved its network with field groups in the process of organising them. We are grateful to Andy Alexander and his colleagues at the Collaborative Ministry of Creighton University for sharing their server with us and for building a website for us.

## Staff of NESRC

We work with a small staff of Dr Walter Fernandes, Gita Bharali, Anamika Deka, Leon Brooks and Khuntala Choudhury. Melville Pereira who was research associate has taken a break for his doctoral studies. Besides, we employed temporary staff for individual projects, for example Vizalenu Khatso as research associate and others as investigators for the study on the tribal customary law, for the case studies on tribal land alienation and developmentinduced displacement in West Bengal, Assam and other States. Our past staff members like Sanjay Barbora and Kazimuddin Ahmed continue to be associated with us

## 1. Research

The mandate of NESRC is to combine research with action. We try to live up to it through our publications, workshops and networking with field groups. During this year we completed four studies. Their follow up is being planned. More studies are in progress and will be completed during 2006-07. A few more projects will be started during this year.

- 1. Gender Implications of the Tribal Customary Law in the Northeast. Walter Fernandes, Melville Pereira and Vizalenu Khatso. September 2005. In most tribal traditions women enjoy a relatively high status without being equal to men. However, many modern inputs that are superimposed on their tradition result in class formation and strengthen patriarchy in their egalitarian societies. Some reinterpret their customary law that is linked to their identity to suit these processes. The study among five tribes, funded by the National Commission for women, looked at its implications and the possibility of modernising their tradition. The National Commission for Women will publish the report in book form. NESRC hopes to bring the leaders of these tribes together to reflect on its findings and to devise strategies to deal with the issues it raises.
- 2. Tribal Land Alienation in the Northeast. The origin of this study funded by the International Work Group for Indigenous Affairs and done in collaboration with the

Indigenous Women's Association of Northeast India is in the macro-study conducted by NESRC on changing land relations in the Northeast. By March 2006 we could complete 8 of the 12 planned case studies in seven States of the Northeast. They were presented at a workshop at Guwahati during which suggestions were made for follow up. Its popular report has been published and a professional report is being planned.

- 3. Development-Induced Displacement and Deprivation in West Bengal 1947-2000: A Quantitative and Qualitative Database: Walter Fernandes, Shanti Chhetri, Sherry Joseph and Satyen Lama. February 2006. During the 2001 Assembly election campaign, the ruling coalition of the State promised to create a climate favouring foreign and Indian private investment. That motivated us to study the impact of displacement in the past because West Bengal was a favourite destination of capital till the 1970s. The study based on more than 20,000 Gazette notifications, 8,000 official files, other research and interviews with knowledgeable persons and 724 displaced families from 13 projects, showed that some 47.6 lakh acres (2 million ha) of land has been used by development projects 1947-2000. It has deprived 70 lakh persons of their livelihood, 20% of them tribals and 30% Dalits. The projects have resettled only around 9% of the persons they displaced. It shows the need for a law and a policy to minimise displacement and to rehabilitate people. This study was funded by Misereor, Cordaid and Missionsprokur.
- 4. Development-Induced Displacement and Deprivation in Assam 1947-2000: A *Quantitative and Qualitative Study of its Extent and Nature:* Walter Fernandes and Gita Bharali. March 2006. The study, the first to be completed in the region and similar to that of West Bengal, is integral to an All India effort to create a reliable database on all displacement and deprivation 1947-2000. It has been completed in 6 States and is in progress in Gujarat. It was funded by Action Aid India, IGSSS and DKA-KFO.

## **Studies in Progress**

- 1. Development-Induced Displacement and Deprivation in Meghalaya, Mizoram and *Tripura*. The displacement studies in these three States had to be interrupted because of lack of funds. We are trying to get money and resume them this year. If we get funds we shall begin the studies also in the remaining four States of the region, including Sikkim. We also plan to do another study on the cost-benefit analysis of the displacing projects.
- 2. An Evaluation of the U.N. Decade of the Indigenous Peoples: At the request of ICIMOD, Kathmandu, NESRC has agreed to do this study with Indian Social Institute, New Delhi, with the directors of NESRC and ISI as coordinators. The UN has launched the second decade of the indigenous peoples 2005-2014 and wants to see the effectiveness of the first. It has three components. Prof. Ritu Dewan of the University of Mumbai is studying the annual budgets 1995-2004 of the Union and of Assam to see to what extent the decade has influenced them. Part II is a study of its impact on the All India policies and those of Assam in the Northeast, Himachal Pradesh in the Northwest and of Jharkhand-Bihar and Chattisgarh-Madhya Pradesh in the East. Its third part is a study of the awareness of the decade among the people and their suggestions for the second decade. NESRC is studying the Northeast.

## 2. Conferences Organised and Attended

Conferences are a way of sharing our experiences of research and field involvement. We ourselves organise some of them and attend and present papers at those organised by others. Research took most of our time during this year and we could organise only a few such conferences or seminars but we took part in many others in the region and outside.

## **Conferences** Organised

- 1. Seminar on Water Resources and Management in the Northeast: At the request of UELCI, Walter Fernandes, Gita Bharali and Sanjay Barbora organised and facilitated two seminars on September 22, 2005 and March 1-2, 2006 on water resources in the Northeast for Lutheran Church leaders from Assam and Manipur. Assam is flood prone and ways have to be found of dealing with it. There is a threat to the water resources of the region because 48 major dams are being planned in the region. Deforestation and environmental degradation show the need for watershed management.
- 2. *Tribal Land Alienation in North Eastern India:* This conference co-sponsored by the Indigenous Women's Forum brought together some representatives of tribals from all seven States, on March 9-11, 2006. The case studies done were presented and discussed and suggestions made for a follow up and networking on the issue of land alienation.
- **3.** Education of Plantation Labourers' Children in Assam: Our 2003 study drew attention to the very low educational status and neglect of the tea garden workers' children but it was difficult for us to follow up on it. When PAJHRA, an Adivasi coordinating body of Assam showed interest in its follow up we agreed willingly to join them in organising a workshop on it on March 22-23, 2006. Walter Fernandes and Gita Bharali functioned as resource persons at it. The meeting funded by the National Commission for Women and attended by around 100 persons analysed the situation of their education and devised strategies to put pressure on the decision-makers to ensure their access to education and to motivate parents to send their children to school.
- 4. *Meeting on the Natural Resources in the Northeast:* NESRC was one of several organisations that came together around this issue when a meeting was held in Guwahati on modes of optimising the use of the region's water and forest resources.

## **3.** Publications

Apart from organising workshops and seminars, we also write in professional journals, books and newspapers. During the year we could only bring out the reprint in English and Assamese, of the booklet on the plantation act, 1951. We also brought out an executive summary of the papers presented at the Conference on Tribal Land Alienation on March 9-11, 2006.

#### 4. Library and Documentation
