NESRC began on March 1, 2000 with a mandate of combining serious research with involvement in the field and encouraging other individuals and organisations to do research on issues of relevance to the Northeast. *Staff of NESRC: Director: Dr Walter Fernandes; Associate Director: Dr Alphonsus D'Souza (Phesama, Nagaland), Research Associates: Gita Bharali, Pranami Garg and Elu Ndang. Librarian: Anamika Deka. Secretary cum accountant: Manisha Kalita.*

While research, the mainstay of NESRC received importance during 2007-08, seminars and networking around peace initiatives received much attention. Two studies were completed during the year and one reached the finishing point. Two more are being launched. NESRC also provided support to research done by some other organisations and individuals. It conducted 17 seminars, 13 of them in 5 States on issues around conflict and peace. Most of them were organised in collaboration with other organisations. These activities and the improvement of the library confirmed the mandate of NESRC.

1. Library and Documentation

During the financial year 2007-08, the library added 2 journals to the 35 that it was receiving already. With more documents and 500 books now the library has 4,000 volumes. While purchasing books priority is given to those on the Northeast. The books were computerised during the year in order to provide better access to the readers. The documentation too will be computerised during 2008-2009

2. Research and Action

NESRC completed two pioneering studies during the financial year and combined them with seminars meant to bring together people involved in issues they dealt with. The first study was a look at the Assam budget from the point of view of children. The second was an alternative to the cost-benefit analysis of people-displacing projects. The report of a third study that has been completed is being finalised. NESRC staff also gave professional support to some others doing research.

1. *Pranami Garg and Madhumita Puryakastha. Assam Budget 2004-05 to 2007-08:* This analysis of the allocations for children, done in collaboration with HAQ, Centre for Child Rights, New Delhi, is the first study of its kind in Assam. The look it takes at the allocations for children's education, development and protection shows that while children are around 43 percent of the population, the allocations are only around 17 percent. Most allocations are for education. Other areas such as development and protection receive scant attention. Some projects such as Applied Nutrition exist on paper but no allocation has been made for them. In addition, implementation of many schemes is weak.

2. Gita Bharali. Alternatives to the Cost-Benefit Analysis of People-Displacing Projects. Studies indicate that some 60 million persons have been displaced or otherwise deprived of livelihood 1947-2000 in the name of national development. Fewer than 20 percent of them have been resettled. The rest are impoverished and marginalized. The study done with support from DKA-KFO was an attempt to see whether after the high price that the displaced pay the projects can be justified even in economic terms. Its first part looked at the cost and time overruns, capacity installation and utilisation of more than 100 projects all over the country. The second part studied the social and environmental costs that the people pay. Projects calculate their cost and benefits exclusively according to the formal economy and exclude the social and environmental costs. Besides, a large number of projects are sanctioned on the basis of 1:1.5 cost-benefit i.e. Rs 1.5 benefit for every rupee sent. The cost and time overruns show

that they do not keep to this criterion but they are rarely evaluated once they are sanctioned. The social and environmental costs are now being quantified. Indications are that if one adds them and the cost and time overruns to the project cost, the benefits will go below 1:1. In the third part, three projects economic, social and environmental of three projects were studied. Their documents were analysed and most persons displaced or deprived by them were interviewed to find out what they had lost to the project, what they had got from it and their present situation. One found signs of overruns in them.

3. Walter Fernandes and Pranami Garg. Development-Induced Displacement 1947-2000 in Meghalaya, Mizoram and Tripura. This study sponsored by Misereor is integral to the All India effort to create a reliable database on all displacement by development projects 1947-2000. Studies have been completed in nine States. In the Northeast it has been done in Assam where the official files speak of 4.2 lakh persons displaced from 3.9 lakh acres when in reality 19 lakh persons have lost their livelihood from 14 lakh acres. The present study continues the effort in the Northeast. Studies are being launched also in Arunachal Pradesh and Manipur. It is hoped to cover the whole region within two years.

4. *Impact of Displacement on the Tribes of Eastern India.* Walter Fernandes and Gita Bharali gave professional support to this study done by Action Aid India together with Laya, Vishakapatnam, Indian Social Institute, New Delhi (ISI) and others. Dr Marianus Kujur of ISI was its coordinator. The older studies were updated in Andhra, Orissa and Jharkhand and a new one was done in Chhattisgarh. Walter Fernandes also did a critique of the Rehabilitation Policy for Mahanirban Calcutta Research Group.

3. Publications

For effective advocacy in support of the marginalized, the findings of the studies have to be circulated in the form of professional and popular publications. Professional publications should reach the regional intelligentsia through the local language. With this in view several publications were brought out during the year, the first of them being a professional Assamese book on displacement. The staff members of NESRC also publish their findings in professional journals, books and newspapers.

4. Seminars and Workshops

Seminars and workshops help one to share knowledge generated at NESRC and get the benefit of what others have produced. During the year NESRC organised more than a dozen seminars by itself or in collaboration with others. NESRC staff members also attended seminars and presented papers at some of them, as a mode of sharing their findings with others, of learning from what others have done and of planning common action. Besides, the peace studies unit of Henry Martin Institute, Hyderabad sent one of their students for placement at NESRC from January to April 2008. Many Indian and foreign scholars and persons involved in advocacy on various issues visited NESRC. We also hosted an interaction with Prof. Patrick Hoenig of Cologne University, on conflicts and peace processes.

Seminars on Conflicts and Peace

A major theme of the seminars organised during the year was conflicts and peace initiatives. Between April and August 2007, NESRC collaborated with other institutions in the region as well as with CRS Guwahati and IWGIA in organising nine one-day seminars on this theme. Many persons are involved in peace-related activities. The effort in these seminars was to provide an umbrella for them to share their concerns with the hope of turning it into a platform for ongoing collaboration among them. These seminars culminated in a two-day Northeast level seminar at Guwahati.

The one-day seminars culminated in the above two-day Northeast level seminar in Guwahati on October 15-16, 2007. It brought peace activists together with student leaders and scholars who could share their work. Its participants felt that in this region of ethnic conflicts history has become a tool both of conflicts and of peace building. Every community rewrites its history to declare itself indigenous to a given area, as such having exclusive rights over all its resources. The participants, therefore, decided to

organise State-level seminars on the history of each State in order to analyse how various communities use this tool. It is hoped that it will be a step towards a composite history of the region as a tool of peace. The following seminars were organised as a result of this initiative.

11. *Consultation of three universities* (Gauhati, Manipur and Martin Luther Christian) that have a peace studies divisions was held at the NESRC office on January 8, 2008 to review the work and to plan some common programmes during the year.

12. *Conflicts and History in Karbi Anglong*, February 23, 2008 in collaboration with Diphu Citizens' Combine for Peace.

13. *The Role of History in Conflicts and Peace in Meghalya:* March 29, 2008, together with the peace studies division of Martin Luther Christian University.

More such seminars will follow during the next six months and they will culminate in a two-day Northeast level seminar at Guwahati in September 2008.

Other Seminars Organised

1. Seminar on Development-Induced Displacement and Rehabilitation in the Northeast.

This two-day workshop organised on November 13-14, 2007 in collaboration with Panos, CASA and RGVN and IWGIA, brought together scholars, social activists and others involved in work among people displaced already or to be displaced by development projects in the Northeast. Rehabilitation is almost non-existent though many more projects are being planned. The situation of persons displaced by projects in the past and those to be affected by them in the future, was analysed and the rehabilitation policy of the Government of India was critiqued. Since displacement will be high in the Northeast during the next few years, the participants decided to work on a rehabilitation policy for the region that can protect the rights of the persons to be affected by the projects. The participants will meet again to reflect on the situation and to formulate a policy.

2. The Assam Budget 2004-2008 from Children's Perspective, Guwahati: January 30, 2008.

Based on the study of the Assam budgets this seminar brought together persons working on child rights in order to understand the budgetary allocations and plan advocacy with the Government of Assam for a higher share and better implementation of projects meant for children. Like the study on which it was based, also the seminar was co-sponsored by HAQ, Centre for Child rights, New Delhi.

3. Gender Implications of the Tribal Customary Laws in the Northeast, Guwahati: Feb. 26-27, 2008

This two-day Northeast level seminar sponsored by the National Commission for Women was held as a follow up of a study conducted by NESRC in 2005 on the gender implications of the customary laws of five tribes in four States. It showed that modernisation without preparing the communities for it, could go against women since with its individualistic value system, the customary laws were being given a stronger patriarchal interpretation than in the past. The seminar brought together scholars, activists and leaders of these and some other tribes to reflect on the situation of gender equity and suggest remedial action. The participants decided to follow up with their own communities.

4. *The Assam Water policy, September 2007.* At the suggestion of a committee member, the Assam Government put its draft water policy for public discussion. Jal Biradari, a civil society network took up the task of organising meetings on it. NESRC took an active part in it. Walter Fernandes joined the preparatory meeting that analysed the draft. Gita Bharali organised six of the seven meetings conducted in eight districts in western and central Assam. The meetings were sponsored by CRS, Guwahati. She also took an active part in the follow up discussion and press conference and wrote about it in the newspapers. The State has prepared a new draft and put it back to the public for its views.

Walter Fernandes was one of the two paneliztz at the Straight Talk programme on Peace in Assam on May 8 and November 11, 2007 and on "Peace in the Northeast" programme on June 7, 2007 and January 15, 2008. He was one of the expert commentators on *Doordharshan Northeast* when State Assembly election results were being declared in Meghalaya, Nagaland and Tripura on March 7-8, 2008. Besides, Gita Bharali was interviewed by more than one TV channel on the Draft Assam Water Policy. Walter Fernandes was interviewed on many occasions on peace initiatives.
