INTRODUCTION

I am happy to present to you the annual report of NESRC for the year 2018-19. NESRC began on March 1, 2000. Its mandate is to combine serious research with involvement in the field and encourage other organisations and individuals to do research on issues of relevance to the Northeast. During the past years, NESRC has tried to live up to this mandate through, research, library, documentation and networking with peace activists and civil society groups who are active among the marginalised or are involved in processes aimed at policy changes in favour of the poor. Its publications and professional and newspaper articles have been other tools of supporting the marginalised.

The study of development-induced-displacement in Northeast India, started in 2005, should come to a close by July 2020. We have already published the reports of the study on Assam, Sikkim, Meghalaya and Nagaland. The remaining states, namely, Arunachal Pradesh, Manipur, Mizoram and Tripura, will be covered latest by July 2020.

Likewise, the multi-year gender impact of customary law study is inching closer to completion. This study looked at the customary law of two tribal communities each of seven Northeastern States from the angle of the rights of women. With three publications of the 14-volume series still remaining to be published, it is hoped that we will bring closure to this study latest by March 2020.

The peace and confliction resolution project organised two seminars. The first seminar focussed on the role of the media in the context of decreasing space for dissent in a democratic India. The second seminar examined the role of women in the resolution of conflicts. During the year, we published one book under this project titled *Living with Conflicts: Possibilities of Peace-Making in the North East*.

During the year, we also completed the study of traditional land management system. Born of this study is a book titled *Ownership, Management and Alienation: Tribal Land in Northeast India*. This book was jointlypublished by North Eastern Social Research Centre and Omeo Kumar Das Institute of Social Change and Development, Guwahati, the sponsor of this study.

As I present this annual report. I want to place on record the contribution made by Late Prof Alphonsus D'Souza, the associate director for over a decade, the

librarian and a senior research fellow of NESRC who passed away on the 6th of September, 2019. Prof. D'Souza's contribution to NESRC is immense. Initially, he was the associate director from 2000 to 2009. Since 2009, he was the librarian and senior fellow at NESRC. He guided many studies some of which have been published. He toiled hard to organise the tribal theology seminars which resulted in the publication of five volumes of edited books. He closely followed the customary law study and guided it right from the start. He was the proof reader of most books published by NESRC. He was also the doctoral guide at Martin Luther Christian University, Shillong, and Assam Don Bosco University, Guwahti. Dozens of doctoral students have benefited from his advice. His passing away is a huge loss for NESRC. May his soul rest in peace.

SEMINARS, WORKSHOPS AND COLLOQUIUMS

- 1. National Seminar on "Centralisation, Democracy and Dissent: The Role of the Media in Contestation and Reconciliation" was organised by the North Eastern Social Research Centre (NESRC) on the 28th and 29th of May 2018 at DBI, Joypur,Guwahati. This seminar brought together media persons, researchers and peace activists involved in a search for alternatives to conflicts emanating from mainstream ideologies today. The invitees presented papers on a gamut of contemporary issues ranging from conflicts in the Northeast to Naxalism or the situation in Jammu & Kashmir, while a few of them looked at the world from the lens of the rural poor, Dalits and Tribals. Some tried to understand the issues that result in nationalist struggles or ethnic conflicts. The objective of the seminar was to provide a platform for the youth and peace activists of the Northeast to know more about the thinking of such persons and to encourage activism in favour of peace and pluralism in the Northeast as well as in other conflict regions of India.
- 2. National Seminar on the "Role of Women in Peace Processes" was organised by North Eastern Social Research Centre (NESRC) on the 2nd and 3rdof November 2018 at Jagriti, Christian Basti, Guwahati. This seminar tried to examine the dual themes of the impact of conflicts on women in the Northeast and elsewhere in India and their role, forms of intervention, capacities and limitations in peace building. Northeast was the point of reference in this seminar. There were participants from different organisations of the Northeast who shared their

experiences keeping in mind the traditional knowledge of the communities that women appropriate to organise peace strategies.
