## Introduction

With immense joy and with gratitude to all those who have supported us during the year we present to you the Annual Report 2020-21 of North Eastern Social Research Centre (NESRC), Guwahati. Despite the obstacles posed by the pandemic during the year, NESRC was able to be quite productive in its research, publications and webinars. We conducted several studies but COVID-19 stopped us from organising local level seminars and meetings of leaders of ethnic communities in conflict which it normally does at Agartala, Bongaigon and Imphal. The meetings that were planned had to be cancelled. Webinars took the place of seminars. The international webinar in July 2020 organised jointly with Don Bosco College, Golaghat focused on tribal land alienation while the national webinar of February 2021 was on fundamentalism in the Northeast. They brought together on a common platform scholars, students, peace activists and civil society leaders to engage with issues around peace and religion. Some staff members presented papers at seminars organised by other institutions.

Publications too suffered because of the pandemic. NESRC offices were closed for many months and printing presses did not function. In spite of it NESRC published five books during the year on land, displacement and gender implications of tribal customary laws. Some staff members also wrote professional and newspaper articles during the year.

The library is being put to good use by research scholars and NESRC continued to improve it. The library has more than 10,000 volumes, around 50 percent of them on the Northeast. These facilities are made available free of cost to scholars and others. The plan to digitalise the documentation centre had to be delayed because of COVID related problems.

In this report we collate details of some of the work done by NESRC from April 2020 to March 2021. This was a year of change. On 1<sup>st</sup> April 2020 Dr Hector D'Souza handed the charge of Director over to Dr Walter Fernandes, its Founder-Director. Some staff members completed their contract and left the centre and others joined and continued its work. They have been productive and have contributed to the mandate of NESRC of combining serious research with networking and action in order to facilitate social change and adapt official policies and social processes to the needs of the marginalised

#### **STUDIES**

Research is the mainstay of NESRC. Some studies were completed during the year and others are ongoing. The main study completed is on the Gender Implications of the Tribal Customary Law in the Northeast. Others included conflicts and peace and land issues.

## A. Studies Completed

**1. Walter Fernandes & Namrata Kalita.** Traditional Conflict Resolution Mechanisms of the Tribes in North East India.

The objective of this study is to bring people together for confidence building measures with long term peace in view. The attempt in this study was to look at the traditions of eight tribes on conflict resolution and possibilities of updating them to suit the present situation.

- **3.** Walter Fernandes, Vanlal Pari, Lalruahmawi Bela and Zonum Wania. Development-Induced Displacement in Mizoram 1947-2010.

These two studies belong to the series undertaken by NESRC from its inception, in order to create a database on the extent and type of land acquired for national development since the first five-year plan, the number and type of people deprived of sustenance, the number rehabilitated and their present state. This database will hopefully be a tool of advocacy for policy changes in favour of the marginalised. Studies in six States have been completed and published. Two more were published during 2020-21 and 3 will be published during 2021-22.

**4. Bineeta Sarma.** The Assam Budget 2020-21 and the Girl Child.

During 2020-21 NESRC resumed the studies that it had interrupted for three years on the child budget in Assam in collaboration with HAQ – Child Rights Organisation, New Delhi. Its focus this year was the girl child, the type of Central and State schemes, Assam's budget allocation for them, the revised estimates and actual spending. Because of the restrictions posed by the pandemic fieldwork could not be done on the nature of their implementation.

## **B.** Ongoing Studies

Five studies being conducted or updated will be completed during 2021-22.

**1. Meenal Tula & Upasana Goswami:** Customary Laws, Land Rights and Women in the Context of Socio-Economic Transformation in Northeast India

The study aims to take a close look at the changing agricultural practices along with land ownership and occupational patterns of women in four communities of Northeast India, the Garo, Karbi, Dimasa and Angami, to better understand the relationship between women and land. These communities provide a suitably varied context with regard to both inheritance patterns and traditional agricultural practices. The Garo, the Karbi and the Dimasa practise shifting cultivation while the Angami are terrace cultivators. While among the Garo property flows through the female line (matrilineal), the other three communities are patrilineal.

- **2. Walter Fernandes & Ratika Yumnam.** Development-Induced Displacement in Manipur 1947-2010.
- **3. Walter Fernandes, Marge Nyori & Dusu Sambyo.** Development-Induced Displacement in Arunachal Pradesh 1947-2010.

These two studies on Development-Induced Displacement (DID) delayed because of the COVID linked restriction, will be completed and published by the end of 2021.

**4. Joseph Zoliana, Theophilus Basumatary, Cassimir Isha Nungchim&Joten Reang.** *The Impact of COVID-19 on the Migrant Workers & Students of Assam, Manipur & Tripura.* 

The nationwide lockdown critically dislocated India's migrant population. Lacking jobs and money, and with public transport shut down, they as well as hundreds of students were forced to return to their homes, at times walking hundreds of miles. The attempt in the study is to understand the processes that led to joblessness and greater poverty among the migrants. Its hypothesis is that the pandemic did not create but intensified the already existing inequalities in the Indian social system. Students too felt the impact of the poor educational infrastructure in the region. The study is being done in the BTAD area of Assam, in Manipur and Tripura.

**5. Joseph Zoliana, Sarah Phanchopi, Samuel Horo and Manpang Nyiam.** Traditional Tribal Conflict Resolution Mechanisms in Nagaland and Karbi Anglong, Assam.

While ethnic conflicts are a reality in the Northeast, it is equally true that the tribes had their traditional conflict resolution mechanisms. By studying the Karbi-Dimasa conflict of 2005 and the ongoing land related Pochury-Chakesang tension in Nagaland an attempt is made to understand the traditional systems and the possibility of updating them to suit present day conflicts. Its hypothesis is that tradition does not have all the answers to present day questions but it can be updated to suit the present and can be modernised to solve the conflicts.

### SEMINARS, WORKSHOPS AND COLLOQUIUMS

Seminars and conferences are basic to the mandate of NESRC to network with civil society groups, researchers, field and legal activists and government officials to reflect together on the social processes and facilitate social and policy changes in favour of the marginalised

- **1.International Webinar** *Politics of Tribal Exploitation in North East India: An Unexplored Slice of Paradise* July 16-17, 2020. Jointly organised by Don Bosco College, Golaghat & NESRC it dwelt on the causes & impact of and possible solutions to tribal land alienation. 2,288 persons from 13 countries registered but attendance was limited to 500.
- 2. National Webinar on Fundamentalism, Secularism and Conflicts in India. February 19-20, 2021. The theme, though All India in nature, was restricted to the Northeast. A national dimension was given to it by Prof. Udayon Misra the keynot speaker. Seven papers were presented, one each from the Seven Sisters of the Northeast. It had 96 participants.

For effective advocacy in support of the marginalised, the findings of the studies and deliberations of the seminars or workshops are made available in the form of professional and popular publications. NESRC published five books during 2020-2021. The first of them was

the last of 14 on the gender implications of the tribal customary law. The book on land relations is an offshoot of the seminar held at Tezpur University in 2018. The one in the conflict and peace series is based on a seminar held in 2019. Two are in the series on DID.

## Ashpriya Rohman

The library of NESRC has been growing in terms of holdings, especially books and journals. These resources are being used by a growing number of students, scholars and researchers. It has earned the name of a specialised library for the kind of exquisite collection of books it has on specific topics in the social sciences and on Northeast India. More than 50 percent of the titles in the library deal with various socio-economic-political aspects of North East India. Its main sections are on women, gender, children, caste, and on the Northeast. 487 new titles were added during 2020-21 and on 31st March 2021 it had 10,111 titles and 30 journals and periodicals. Some journals are preserved as bound volumes for future reference. The library is used by the researchers NESRC and also by students and scholars from various colleges and universities. The institutions whose sscholars used it during 2020-21 include TISS (Tata Institute of Social Sciences), Guwahati, NEF group of Colleges, Guwahati University, Assam Don Bosco University, Assam University, Silchar, JNU, IIT, Delhi University, Jamia Milia Islamia. We have also welcomed some foreign scholars doing research on the region. Also some journalists and activists are among its users. Free access to the library ensures its wider usage. During 2021-22 the library catalogue will be uploaded on the NESRC website in order to make it easier for the users to access it.

The documentation centre has more than 200,000 paper cuttings of the last two decades on various issues concerning the world, India and the Northeast. The plan to digitalise them from January 2021 had to be delayed by a year because of COVID related problems.
